## **Early Market Engagement**

Request for Information in connection with Decommissioning of an Existing Chick Setter and Hatcher & Supply, Installation, Testing and Commissioning of new Chick Multistage Setter and Hatcher

(Authorised under Directive No 25 of the Procurement Policy Office)

#### <u>Objectives</u>

The Poultry Breeding Centre (PBC), under the aegis of the Animal Production Division of the Ministry of Agro Industry, Food Security, Blue Economy and Fisheries, operates a broiler parent stock farm at Reduit which produces hatchable eggs for incubation in its hatchery. Up to 6000 broiler chicks are produced every week from the hatchery for sale to some 300 registered farmers. The Centre wishes to replace its existing incubator with new equipment to sustain its operations in the long-term. The new incubator should fit into the existing infrastructure at the PBC, Reduit.

In order to procure the best solution available on the market, this Ministry is conducting a Request for Information exercise from potential suppliers for an upcoming competitive bidding exercise to be carried out during the course of this financial year.

### <u>Submission</u>

- Ability to provide repairs and maintenance facilities for the equipment.
