EXPRESSION OF INTEREST RENTAL OF WOODEN STALLS FOR LES ASSISES DE L'AGRICULTURE AT COTE D'OR NATIONAL SPORTS COMPLEX FROM 16th TO 20th MARCH 2023. A. STATEMENT OF REQUIREMENTS

1. INTRODUCTION

The Ministry of Agro-Industry & Food Security is inviting expression of interest from eligible and qualified local participants for the supply, set up (pre event) and dismantling (post event) of 142 stalls for the event – Les Assises De L'Agriculture, scheduled on 16th to 20th March 2023 at Cote D'Or National Sports Complex.

2. SCOPE OF WORK

The work included in this contract comprises the provision of all equipment, labour and materials of whatever kind necessary for the complete and proper set up and dismantling of 142 stalls for the event.

The works shall generally include the following:

1. Manufacture, supply and install 142 wooden stalls as per layout SAL-01.

2. Stalls shall be of dimensions 2.5m x 2.5m and height 2.5m and the structure proposed is as per layout SAL-02, made up of treated pine wood 75mm x 75mm.

3. The stalls shall be manufactured and/or prepared and the final structures shall be ready for assembly, tentatively, two days, prior to the event.

4. All stalls shall be assembled on site, without causing any damage to the ground and amenities, and all structures need to be installed prior to the first event day.

5. After the event, all stalls shall be dismantled and removed from the hall and all materials shall be taken away by the service provider.

6. Cleaning and carting away of all debris arising from the assembly and after the dismantling of the wooden structures, at approved site.

Note to local participants:

a. The structures shall be fixed on ground and shall be of sufficient strength to withstand on its own weight and safe for users and the public.

b. Layout SAL-02 is only a proposal. Other proposals are welcomed, for consideration, complying with the requirements set.

c. Bidders are advised to visit and inspect the site for which they are tendering prior to submission of their respective offer as no claims will be allowed on the grounds of ignorance of the conditions under which the works will be executed.
