<u>Vacancies for Post of Technical Officer/Senior Technical Officer</u> (Conservation)

Ministry of Agro-Industry, Food Security, Blue Economy and Fisheries (Agro-Industry and Food Security Division) (National Parks and Conservation Service)

Applications are invited from qualified officers of the Ministry of Agro-Industry, Food Security, Blue Economy and Fisheries (Agro-Industry and Food Security Division) who wish to be considered for appointment as Technical Officer/Senior Technical Officer (Conservation) in the National Parks and Conservation Service of the Ministry.

II. QUALIFICATIONS

By selection from among officers of the Ministry who reckon at least two years' service in a substantive capacity in their respective grade and who possess -

- (i) a diploma in Agriculture or Agriscience and Technology or Biology or Zoology or Botany or Ecology from a recognised institution <u>or</u> an equivalent qualification acceptable to the Public Service Commission; and
- (ii) effective organising, communication and interpersonal skills.

NOTE

Selected candidates will be appointed in a temporary capacity in the first instance and will be required to undergo training, both theoretical and practical, in all aspects of conservation for a period of at least one year. On satisfactory completion of the training and on being favourably reported upon, they will be considered for appointment as Technical Officer/Senior Technical Officer (Conservation) in a substantive capacity.

III. DUTIES AND SALARY

- 1. To be responsible to the Scientific Officer (Conservation) or any senior officer designated by the Director, National Parks and Conservation Service or Deputy Director, National Parks and Conservation Service in the performance of the following duties
 - (i) the conduct of fauna, flora, wetlands conservation and research work;
 - (ii) interpretation activities including dissemination of conservation information; and
 - (iii) sensitisation programmes including the preparation of displays/brochures related to conservation of terrestrial flora, fauna and wetlands.

- 2. To participate in management expeditions to islets around Mauritius and Rodrigues and to the Outer Islands of the Republic of Mauritius.
- 3. To be responsible for the day-to-day management of National Plant Propagation Centre, Rivulet Terre Rouge Estuary Bird Sanctuary and Gerald Durell Endemic Wildlife Sanctuary, when posted thereat.
- 4. To use ICT in the performance of his duties.
- 5. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Technical Officer/Senior Technical Officer (Conservation) in the roles ascribed to him.

NOTE

Technical Officer/Senior Technical Officers (Conservation) will be required to work outside normal working hours, including Saturdays, Sundays and Public Holidays.

The permanent and pensionable post carries salary in scale Rs $22,625 \times 400 - 23,425 \times 525 - 26,050 \times 675 - 27,400 \times 825 - 35,650 \times 900 - 37,450 \times 950 - 42,200 \times 1,300 - 46,100 \times 1,575 - 49,250 \times 1,650 - 54,200$ a month.
