VACANCY FOR THE POST OF STORES ATTENDANT

Applications are invited from employees on the permanent and pensionable establishment of the Ministry who wish to be considered for appointment as Stores Attendant in this Ministry.

2. QUALIFICATIONS

By selection from among employees on the permanent and pensionable establishment of the Ministry who –

- i. possess the Certificate of Primary Education;
- ii. have a good knowledge of measures and measurements; and
- iii. are familiar with common items of stores in use in all stations of the Ministry such as chemicals (including fertilizers) and seeds.

NOTE

In the absence of candidates possessing the qualifications at (i) above, consideration will be given to employees on the permanent and pensionable establishment of the Ministry who show proof of being literate.

3. DUTIES

- 1. To be responsible to the officer in charge of stores for
 - (i) opening and closing of stores apertures, as required;
 - (ii) cleaning the stores premises;
 - (iii) collecting, loading, unloading and conveying stores items;

- (iv) opening packages, crates and cases;
- (v) handling and packing all stores items, as required;
- (vi) removing all packing materials, empty crates to appropriate places for their eventual disposal;
- (vii) washing, cleaning and stowing empties;
- (viii) issuing petrol to drivers;
- (ix) placing and arranging items of stores on shelves and maintaining them clean and in an orderly manner
- (x) collecting and despatching stores correspondence, as required; and
- (xi) assisting in work relating to inventories and surveys.
- 2. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Stores Attendant in the roles ascribed to him

4. <u>SALARY</u>

The permanent and pensionable post carries salary in the scale of Rs $13975 \times 250 - 15225 \times 260 - 17825 \times 275 - 18925 \times 300$ -19525 x $325 - 21475 \times 375 - 22225 \times 400 - 23025$ a month plus salary compensation at approved rates.

The selected candidates will, in the first instance, be appointed in a temporary capacity for a period of six months. At the end of the temporary period, on their being favourably reported upon, consideration will be given for their substantive appointment.

Appointment in a temporary capacity in the grade carries a flat salary at the rate of Rs 13,975 a month plus salary compensation at approved rates.

5. MODE OF APPLICATION

- (a) Qualified candidates should submit their applications in **duplicate** on the enclosed prescribed Application Form as follows:

- (b) Photocopies of birth and educational certificates and the National Identity Card should be submitted along with applications and applicants should produce the originals as and when called upon to do so.
- (c) The envelope should be clearly marked on the top left-hand corner "Post of Stores Attendant, Ministry of Agro-Industry, Food Security, Blue Economy and Fisheries (Agro-Industry and Food Security Division)".
