# VACANCY FOR THE POST OF SANITARY ATTENDANT

Applications are invited from employees on the permanent and pensionable establishment of the Ministry who wish to be considered for appointment as Sanitary Attendant in this Ministry.

## 2. **QUALIFICATIONS**

By selection from among employees on the permanent and pensionable establishment of the Ministry who possess the Certificate of Primary Education.

# **NOTE**

In the absence of candidates possessing the Certificate of Primary Education, consideration will be given to candidates who show proof of being literate.

#### 3. <u>DUTIES</u>

- 1. To clean lavatories, bathrooms and water basins.
- 2. To assist Office Auxiliary/Senior Office Auxiliary to keep offices and office premises clean and tidy.
- 3. To perform such other duties directly related to the main duties listed above or related to the delivery of the output and results expected from the Sanitary Attendant in the roles ascribed to him.

# 4. <u>SALARY</u>

The permanent and pensionable post carries salary in scale Rs  $13,745 \times 230 - 13,975 \times 250 - 15,225 \times 260 - 17,825 \times 275 - 18,925 \times 300 - 19,525 \times 325 - 21,475 \times 375 - 21,850$  a month plus salary compensation at approved rates.

The selected candidates will, in the first instance, be appointed in a temporary capacity for a period of six months. At the end of the temporary period, on their being favourably reported upon, consideration will be given for their substantive appointment.

Appointment in a temporary capacity in the grade carries a flat salary at the rate of Rs 13,745 a month plus salary compensation at approved rates.

# 5. <u>MODE OF APPLICATION</u>

- (a) Qualified candidates should submit their applications in **duplicate** on the enclosed prescribed Application Form as follows:
  - (i) Part A of the original to be filled in by candidates and submitted directly to the Senior Chief Executive, Ministry of Agro-Industry and Food Security, Human Resource Section, 5<sup>th</sup> Floor, Dentamax House, Dumas Street, Port Louis, not later than 3.00 p.m on Wednesday 11 October 2023; and
  - (ii) the **duplicate** through their respective Head of Division/Section/Unit who will forward it duly completed and stating, where applicable, the periods during which the applicant has performed duties of Sanitary Attendant, to the Human Resource Section, 5<sup>th</sup> Floor, Dentamax House, Dumas Street, Port Louis <u>within a week</u> <u>after the closing date</u>.
- (b) Photocopies of birth and educational certificates and the National Identity Card should be submitted along with applications and applicants should produce the originals as and when called upon to do so.
- (c) The envelope should be clearly marked on the top left-hand corner "Post of Sanitary Attendant, Ministry of Agro-Industry and Food Security".

# 6. <u>CLOSING DATE</u>

Qualified candidates should submit their applications to the **Senior Chief Executive**, Ministry of Agro-Industry and Food Security, Human Resource Section, 5<sup>th</sup> floor, Dentamax House, Dumas Street, Port Louis so as to reach her **not later than 3.00 p.m on Wednesday 11 October 2023.** 

# 7. <u>IMPORTANT</u>

- (i) Qualifications obtained <u>after</u> the closing date <u>will not be accepted</u>. Only qualified persons should apply. The onus for the prompt submission of applications so that they reach the Senior Chief Executive, Ministry of Agro-Industry and Food Security in time, lies solely on applicants.
- (ii) Incomplete, inadequate or inaccurate filling of the application form may cause the elimination of candidates from the competition. This may lead to an application being rejected or, if a candidate has already been appointed, to the termination of his appointment.
